



TRUSTEES' REPORT

The Trustees are pleased to present their annual report together with the financial statements of the Charity for the year ending 31st March 2019 which are also prepared to meet the requirements for a directors' report and accounts for Companies Act purposes.

The financial statements comply with the Companies Act 2006, the Memorandum and Articles of Association, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Objectives and Strategies

We work to inform, support and empower people with aphasia and their families to manage their communication disability and to re-engage with life.

We create an aphasia-friendly community in which people feel included, valued and have a sense of purpose.

Our three main objectives are to grow our core services, extend our outreach and continue to develop as a centre of expertise.

Our Main Services

- A 'Learning to Live with Aphasia' programme focussing on developing communication strategies and psychosocial adjustment.
- A dynamic 'Moving On' programme for people who are looking for change and challenge.
- "Conversation and Support" groups providing the security of long-term aphasia help.
- 'Conversation Partners' courses, enabling couples to manage aphasia more successfully.
- A phased support service for people living with Primary Progressive Aphasia.
- A programme of special interest courses and activities.
- Training and awareness raising.

WHAT IS APHASIA?

Aphasia affects a person's ability to find words and to understand language, both spoken and written.

Aphasia ranges from mild to severe and can be a long-term condition which impacts whole families.

It is isolating, frustrating and is usually acquired without warning, most often through stroke but can be a result of a brain injury or rare dementia called Primary Progressive Aphasia (PPA).

Public Benefit

The Trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives, and in planning future activities.

Achievements and Performance

In 2019 we marked our 25th year of service to people with aphasia in Surrey. Our original vision, of a world where people with aphasia can find opportunity and fulfilment, remains unchanged.

Dyscover remains one of the only specialist providers of comprehensive, long-term, structured aphasia support programmes in the UK. Our move to Leatherhead in February 2018 resulted in longer journeys for over half our members. Their continued attendance demonstrates the value they place on Dyscover.

This year our contribution to the community has been recognised and rewarded as being outstanding. Dyscover has been honoured with The Queen's Award for Voluntary Service, the highest award made to volunteer groups across the UK.

Before the announcement in June 2019 that Dyscover had received the Queen's Award for Voluntary Service, staff and volunteers joined representatives of Surrey charities that had been nominated for the award at a reception hosted by the High Sheriff of Surrey, Jim Glover.

Other significant achievements this year

- Shared our expertise in the long-term management of aphasia at both UK and international events.
- Restructured our leadership to enable a greater focus on developing outreach services.
- Extended our special interest activities, offering more sessions and a wider range of aphasia-accessible sports and arts opportunities.
- Strengthened our Board, replacing our outgoing Chair and Treasurer and recruiting two new Trustees with skills in business development and change management.

We are honoured that The Lady Fellowes of West Stafford, LVO, has accepted the role of Dyscover's Patron.



The things we do here are challenging in a good way.

After a stroke at 48, Niki was overwhelmed to find that her mild aphasia meant she could not return to her job.

"Until I came to Dyscover, I didn't really understand about aphasia. I was so low in confidence."

Now she enjoys meeting her friends, "younger people with aphasia like me. You don't have to explain yourself."

Services: Performance and Impact

Dyscover's services focus on building everyday communication skills that are relevant to the individual. We help people with aphasia to regain skills, develop confidence and to recover a sense of purpose and value in life.

We aim to be both a support and a motivation, encouraging our members to progress from 'patient' to active citizen, through targeted group support programmes.

Group Support Programmes

Weekly group support sessions for people with aphasia form our core service.

This year we provided 246 weekly support sessions to 84 men and women with aphasia, over a third of whom are under 65. 90% of these group members have aphasia caused by stroke. We have responded to 71 new referrals with individual advice, assessment and, where appropriate, introduction to a Dyscover group.

Our three different programmes are designed to meet people's needs as they recover and adjust to their aphasia. 'Learning to Live with Aphasia' equips people with an understanding of their aphasia and strategies to manage in conversation. 'Moving On' focuses on building competence, confidence and participation. 'Conversation and Support' offers a long term aphasia-friendly community to maintain skills and counteract isolation.



Group activities take the needs of each member into account.

Support for Families

Family members play a vital role in the recovery and adjustment of people with aphasia.

This year we offered 21 relatives' meetings within our groups and access to individual information and advice from our specialist Speech and Language Therapists.

Five couples living with aphasia took part in a six-week Conversation Partners' course, all of whom reported improvements in the success and enjoyment of their conversation.

100% of relatives say they 'highly value' the security of knowing Dyscover's support is long-term.

88% of relatives said they were highly satisfied with the specialist support provided at Dyscover.



Dyscover has given me a reason to feel positive.

"Dyscover's support for my husband supports me as well. Every member of the very professional staff is friendly and caring, focussing on the positive. I feel encouraged that we will cope and enjoy life – and we do!

Meeting other relatives at fundraising events helps you gain advice from each other and relax. You know that you are far from being on your own; it is like a family.

We laugh, too, a valuable therapy in itself."

Services: Performance and Impact

Primary Progressive Aphasia

Primary Progressive Aphasia (PPA) is a rare dementia affecting parts of the brain that process language.

Since 2015 Dyscover has been pioneering and developing a unique phased intervention and support programme for groups of couples living with PPA. This year we supported 46 people through telephone advice, two early-stage workshops, two six-week conversation training courses for couples, and two follow-on sessions.

Our work has attracted interest from professionals. This year our Director of Service was invited to speak about our PPA programme at the UK Dementia Congress and the Aphasia Symposium of Australasia, and was interviewed for the Dementia Researcher podcast.

Outreach, Training and Awareness Raising

One of Dyscover's primary objectives is to share our skills and knowledge, raising public awareness of the condition and reaching more people with aphasia.

TRAINING AND VISITOR SESSIONS

17 professionals visited Dyscover to observe sessions and learn about our services.

We delivered three full-day training sessions to equip new staff and volunteers within Dyscover as well as eight external participants.

The value of our training has been recognised by TALK Surrey and The Grange residential centre who have commissioned us to deliver bespoke training to their organisations.

APHASIA AMBASSADORS PRESENTATIONS

Eleven members volunteered as Aphasia Ambassadors, speaking directly to over 800 audience members in 30 awareness-raising presentations.

REACHING MORE PEOPLE WITH APHASIA

People with aphasia after stroke are often compromised by additional health concerns, depression and transport difficulties. This means not all the people referred to us go on to join Dyscover.

Sometimes distance is a problem. Dyscover's Kingston satellite continues to play a key role,

catering for a third of members. We have established relationships with a partner organisation in South West Surrey with a view to running a pilot course in this location for people with post-stroke aphasia.

Support for PPA remains scarce. As a result of publicising our courses we have attracted participants from Kent, Hampshire, West Sussex, and Essex. Following our successful PPA course at Odiham, we helped re-establish a regional support group which now meets the needs of people in Hampshire, Berkshire and Dorset.

social Media Facebook and Twitter are enabling Dyscover to reach a wider audience. This year our Twitter following increased by more than 40% as we shared information with aphasia organisations and professionals in the UK and abroad. Regular posts on Facebook gave updates on our activities.

Services: Performance and Impact

Extra Activities

In addition to our core service, we encourage members to take up new opportunities and challenges to boost their confidence and participation.

We do this through aphasia-accessible courses and one-off special interest days, which this year included 11 different arts and physical activities. Our ten-week courses of swimming and golf were both fully subscribed, whilst music and art workshops engaged 61 members. A third of our members participated in Easter and Summer taster activities.



The dedicated instructor at the Dorking swimming sessions challenged members with new tasks each week.

We are grateful to Awards for All and Mole Valley District Council for funding this programme.

Professional Links and Research

Linking with clinicians and researchers ensures our services remain evidence-based and provides opportunities to develop partnerships which benefit the organisation and people with aphasia.

Our membership of The Aphasia Alliance, The Stroke Association and The Dementia Action Alliance brings us into contact with fellow professionals working in the fields of aphasia, stroke and dementia.

We engaged in research projects with City University, University College London (UCL), and Healthwatch Surrey.

We committed to providing educational opportunities and supervision for three students on the MSc Speech and Language Sciences programme at UCL.

We shared our expertise in presentations to Queen Elizabeth's Foundation for Disabled People, Surrey Hills Rehab, Innovations in Dementia, and Rare Dementia Support.

We presented our work at the UK Dementia Forum, the Australian Aphasia Association Conference, and the Aphasia Symposium of Australasia.



Our Director of Service attended and presented at two aphasia conferences in Australia. The British Aphasiology Society gave a travel bursary towards the costs of the trip.

Measuring our Impact

Progress towards individual goals is monitored and measured by our therapists on an ongoing basis. We use feedback forms and video analysis to assess the gains made by participants in our conversation partners' courses for couples.

Our annual satisfaction questionnaire indicates that Dyscover members and their relatives highly value the services we offer.

100% of relatives and **82%** of members highly value the security of long-term support.

75% of members and **100%** of relatives gave Dyscover an overall rating of 8/10 or higher.

88% of participants in our 'Learning to Live with Aphasia' and 'Moving On' groups reported improvements in their communication over the past year.

81% of people in our Learning to Live with Aphasia and 'Moving On' groups were highly satisfied with the encouragement to continue their recovery.

Across all our groups, **77%** said they were highly satisfied with the friendships that have grown out of attending.

88% of relatives tell us that they are highly satisfied with the specialist support we provide.

79% of members highly value input to their groups by Speech and Language Therapists.

People

Trustees

Changes to the Board have been achieved with minimal disruption. John Woollatt succeeded Gill Jackson as Chair of Trustees, following her retirement in October 2018. Stuart Knee has taken on the positions of Treasurer and Company Secretary. The Board has gained additional skills and experience through the recruitment of two Trustees with backgrounds in staff development, change management and business leadership.

Management Team

This year our Trustees have helped support and guide senior staff in their desire to achieve a new leadership structure which makes best use of staff skills, and positions Dyscover for future growth and development.

As a result, Alice Owen was promoted to Director of Business, focussing on finance, fundraising, marketing and HR. Rosemary Townsend, as Director of Service, now oversees service delivery, development and outreach.

Staff

Our part-time staff team of nine includes three specialist Speech and Language Therapists (SLTs) and three SLT Assistants. In our annual satisfaction questionnaire, 81% of members and relatives rated SLT leadership as 'highly important'

We have invested in additional community fundraising hours to help us meet our targets.

Volunteers


We have benefitted from the skilled support of 36 committed volunteers who worked directly with members in our conversation groups and 18 who supported marketing, fundraising and governance. Six of our volunteers received service awards from their local boroughs.

Community fundraising events and activities also rely on volunteers to maximise success.

We actively encourage and support people with aphasia to consider volunteering as part of their ongoing recovery. At least a quarter of all members currently engage in some type of volunteering, from acting as an Aphasia Ambassador for Dyscover, to roles in research, fundraising or community activities.

Our Future Plans

Trustees and staff will review and update our strategic plan, focussing on:

- Developing our evidence-based therapeutic group support, responding to what members and relatives say they want and need.
- Engaging more people with aphasia in our services through partnerships and outreach.
- Developing our centre of expertise, strengthening links with academic institutions as well as seeking opportunities to share at conferences and offering training.

Financial Review

The accounts distinguish between Restricted and Unrestricted funds and indicate the amounts expended during the year in each category. This distinction is more fully explained in Note 1 to the Accounts.

This financial year has been challenging for Dyscover, following the relocation of the main operations from Walton-on-the-Hill to Leatherhead. Our staff and our members have now settled in well to the new premises, but the disruption of the move adversely affected our fundraising, resulting in a fall in the level of income received from charitable grants. However, these difficulties have now been overcome and we have a robust fundraising strategy and a strong Fundraising Committee in place.

Total incoming resources for the year decreased from £225,829 last year to £190,417 this year. Revenues from Unrestricted donations, grants and subscriptions reduced from £87,770 last year to £67,598 due to reductions in the donations from business organisations and charitable trusts. Restricted funds from charitable trusts also reduced this year to £59,791 compared with £71,295 last year.


Total resources expended during the year reduced from £218,939 last year to £203,831 this year, of which £188,744 was spent on charitable activities. All these factors resulted in an overall reduction in retained funds in the year of £13,414, of which £19,902 arose within Unrestricted funds, offset by an increase in Restricted funds of £6,488.

Total funds carried forward at 31st March 2019 stood at £140,274, of which £124,814 was unrestricted, representing 7.5 months of total expenditure for the year. This meets the Trustees' policy of retaining a fund equivalent to between 6 and 12 months' expenditure and is a prudent level to hold in view of the uncertainty regarding future grants.

As a charity, Dyscover is dependent on the kind help given by a range of charitable trusts and funds, the generosity of individual donors and support 'in kind', for which we are very grateful. Trusts and other organisations supporting us are listed below and we are especially grateful to our major donors.

Local Fundraising

This year we launched two major initiatives to stimulate support. During our AGM we shared information about leaving a gift in a Will for Dyscover, encouraging supporters to think about investing in the future of Dyscover – just 1% left in a legacy can be hugely beneficial to a small charity. We have also begun our 25th anniversary celebrations and launched our 'Raise £25 for Dyscover Challenge'.

Individual Donations

Regular and one-off donations from individuals amounted to £29,471 for which we are most grateful.

Sponsorships

We would like to thank all those who walked, ran, cycled and took part in sponsored events raising £13,561. A special mention must go to our volunteer Mandy Nickerson *(pictured below)* who ran the London Marathon and held a Wellbeing Day, raising more than £8,000 for Dyscover over the past two financial years.



Events

Open Gardens, Bridge Evenings, Pub Quiz Nights, Santa Runs, a Fashion Show, and a Pop-Up Shop, were among this year's events and raised a total of £7,195. We are very grateful to everyone who gave their time to organise and support these events.

Community Groups

Thanks to all the community groups who support us by holding events for us or by adopting Dyscover as their charity of the year. This continues to be a valuable source of funds, raising £5,210

Top Draw

Thanks to the generous support of Top Draw Club members, the club has raised $\pounds 2,750$ for Dyscover. The club is a quarterly prize draw competition with annual subscriptions from $\pounds 10$, with 50% of the price of each share going to Dyscover and the rest distributed in prizes. The club is regulated under the provision of Gambling Act 2005.

Gift Aid

The value of donations and sponsorship has been significantly increased by tax claimed back through Gift Aid. Our thanks to everyone who completed the necessary declaration.

Business Engagement

We have recruited a volunteer to coordinate our collection tins and to go out into the local community and engage with local business. Volunteer David has placed 12 additional tins in the local area this year and this has raised £296.



Looking Ahead

It remains our priority to seek and secure income from a broad range of sources and keep our group fees as low as possible.

We look to sustain and improve relationships with grant-making trusts and foundations. We aim to increase our project funding by continuing to make people aware of the impact of our work. It is our policy to be open and transparent; we welcome visits and contact.

Our Trustees continue to engage better with local corporations and businesses, with the aim of developing mutually beneficial partnerships and increasing opportunities to raise awareness in our local communities.

Our 25th Anniversary celebrations, together with fundraising events and individual initiatives, will play a significant part in our fundraising strategy for 2019-20.

governed by its Memorandum
and Articles dated 14th June
2003. It is registered as a
charity with the Charity
Commission. In the event of
a winding up, if necessary,
every member of the charity
undertakes to contribute up
to £10 for payment of the
charity's debts and liabilities.

Risk Management and Internal Control

Our Trustee Board continues to comprise members with the broad base of skills necessary for the good governance of Dyscover.

The Trustees have continued to assess the major risks to which Dyscover is exposed. The Board are satisfied that Dyscover has established review systems that under normal circumstances, should allow these risks to be managed and mitigated to an acceptable level in its day-to-day operations.

The Board maintains and monitors an established system of financial controls appropriate to the size and nature of the organisation, including budgetary control and reviewing the annual budget. Particular attention is paid to the balance between income and expenditure and the amount necessary to be retained in reserves.

We have a regular review schedule of Dyscover's policies and procedures including: health and safety, equalities and diversity, recruitment and selection, as well as the services provided by Dyscover, with a view to mitigating any associated risks.

Trustees' responsibilities in relation to the financial statements

The Trustees (who are also directors of Dyscover Limited for the purposes of company law) are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with the applicable law and the United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the Trustees to prepare financial statements for each financial year. Under company law the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period.

In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgments and estimates that are reasonable and prudent;
- state whether applicable UK accounting standards have been followed, subject to any departures disclosed and explained in the financial statements; and
- prepare the accounts on a going concern basis unless it is inappropriate to presume that the charity will continue in business.

The Trustees are responsible for maintaining proper accounting records which disclose with reasonable

accuracy at any time the financial position of the charitable company and to enable them to ensure that the accounts comply with the Companies Act 2006.

They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities

Notes to the Accounts

Notes to the Financial Statements for the Year ended 31st March 2019

1. Accounting Policies

Basis of Accounting

These accounts have been prepared under the historical cost convention and in accordance with:

The Statement of Recommended Practice; Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and with The Companies Act 2006.

Depreciation Policy

Provision for depreciation of fixed assets held for use by the Charity is made at annual rates calculated to spread the cost (less anticipated residual disposal value) of each asset evenly over its expected life. The depreciation rate currently in use for Furniture and Fittings is 20% on cost. Equipment acquired by using Restricted Funds is written off in full in the year of purchase.

Funds Accounting

Restricted Funds are funds that are to be used in accordance with specific restrictions imposed by donors. Any expenditure incurred on a specific project in excess of restricted funds available will be treated as expenditure from Unrestricted Funds.

Unrestricted Funds are Accumulated Funds that are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for any other purposes.

Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the items of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from grants is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

For legacies, entitlement is taken as the earlier of the date on which either, the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the charity that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the charity, or the charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material.

The value of services provided by volunteers has not been included in these accounts.

Expenditure and Allocation of Costs

Expenditure is recognised on an accrual basis as a liability is incurred and includes any VAT which cannot be recovered which is reported as part of the expenditure to which it relates. Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. Governance costs include those costs associated with the constitutional and statutory requirements of the charity and include the fees of the independent examiner and costs linked to the strategic management of the charity.

All costs are allocated between the expenditure categories of the SoFA on the basis of actual costs

incurred on a particular activity, thereby reflecting the use of the resource.

Pensions

Employees of the charity are entitled to join a defined contribution 'money purchase' scheme. The charity contribution is restricted to the contributions disclosed in note 9. There were no outstanding contributions at the year-end. The costs of the defined contribution scheme are included with the associated staff costs and allocated therefore to raising funds, charitable activities, support and governance costs and charged to the restricted/unrestricted funds of the charity.

Operating Leases

Rentals applicable to operating leases are charged to the income and expenditure account on a straight line basis over the term of the lease.

2. Trustees' Remuneration and Expenses

No remuneration directly or indirectly out of funds of the Charity was paid or payable for the period to any Trustee or to any person or persons known to be connected with any of them.

Two Trustees have been reimbursed £202 travelling expenses (2018 £343) claimed in carrying out their duties.

The Charity has put in place Trustee Indemnity insurance as part of its overall indemnity insurance with an annual premium of £100.

3. Taxation

As a registered charity, Dyscover Ltd is exempt from tax on its charitable activities. No tax charges have arisen in the current or previous year.
