Rules of the Dyscover Top Draw Club

1. Only subscribing members of the Dyscover Top Draw Club are allowed to participate in the draw.
2. The only right attaching to membership is eligibility to participate in the draw.
3. Subscriptions for each share shall be £10 per annum payable by Standing Order only.
4. Any member who falls into arrears shall forfeit automatically the right to be included in any subsequent draw until the arrears are paid.
5. Every share purchased shall, subject to Rule 4, participate in the quarterly prize draw and the bonus draw in December of each year. Subscribers in any calendar quarter will be eligible for the draw of the following quarter.
6. On no account shall the promoter pay any prize money to any person other than the purchaser of the winning share.
7. No subscription money will be refunded.
8. If there is insufficient interest to continue the draw the remaining funds available for prizes will be distributed by way of a final draw.
9. The Board of Trustees has duly appointed Simon Northam as Promoter of the Draw.
10. In the event of any dispute the decision of the Promoter and the Board of Trustees of Dyscover shall be final and binding.
11. 50% of all subscriptions shall be returned to members as prizes. The other 50%, less expenses, shall be passed to Dyscover, Registered Charity No. 1099432.
12. Prizes shall be distributed to winners immediately after each draw. All participants shall be advised of prize winners on Dyscover's website.
13. The competition is conducted under the provisions of the Small Society Lottery Gambling Act 2005 Schedule 11.
14. Purchasers must be 18 years of age or over.
